JUNE MEMBERSHIP MEETING AT WOLFF FARM

On June 12, Medina County Historical Society had a special members only meeting and program. Over forty members met at the Wolff properties to enjoy a potluck meal, learn about farming in the Medina County, and experience the wonders of milking cows.

Kara Wolff, a member of the Wolff family, gave a brief history of the farmstead. It started in the 1860s when Adolff Wolff came to town and settled in the area. He owned the entire area and most of the family lived in houses on the street named after him. As a bit of history, in 1948, there were 1800 licensed dairy farms in Medina County. There are only about a dozen left today. Since 1950 Ohio has lost about 2 million acres of farmland.

Kara works for a dairy lab and explained that each load of milk is monitored for quality and antibiotics. The Wolff farming operation is proud of its heritage and takes conservation seriously. They have been awarded conservation district awards and believe that one needs to take care of the land. The Wolff farm is a dairy farm. It milks about 60 cows twice a day. In addition to the cows, they also grow hay, soybeans, and corn. It is a very extensive and earth conscientious operation.

Kara ended the talk with an interesting demonstration. She took an apple and cut it into four equal parts. Three of those parts represented the oceans. The last fourth was cut in half and that 1/8 section represents land that is deserts, swamps, mountain, Artic and Antarctic areas. The last 1/8 section represents land where people can live and may be able to grow food. If you cut that last 1/8 section into 4 parts – three of those represent land that is too rocky, wet, or developed. That leaves 1/8 of $\frac{1}{4}$ or (1/32) of the apple to grow all the food. This is for the entire world, not just the USA.

We are fortunate to still have men and women willing to do the hard and endless work of farming.

SNAPSHOT OF A CIVIL WAR VETERAN

In 1850, there were two Medina County families who were destined to move on. By 1860, the Bartlett family, from Brunswick, traveled a short distance to Strongsville in Cuyahoga County, while the Hopkins family, from Sharon Center, journeyed across the country to Iowa. Each family was to have three sons enlist in the Civil War and only have one survive.


In both families, all the sons enlisted in the same regiment with the Bartletts in Company A of the 124th Ohio Volunteer Infantry and the Hopkins in Company E of the 15th Iowa Volunteer Infantry.

Frederick Bartlett entered the war as a private with Company A 124th OVI and mustered out as captain of Company D 27th United States Colored Troops. Frederick returned to Strongsville after the war and resumed his occupation as shoemaker. He died in 1899 and is buried at Butternut Ridge Cemetery in North Olmsted. Edward Bartlett was a corporal of Company A 124th OVI and died of wounds suffered in battle. He is buried at Nashville National Cemetery. John Bartlett was a private in Company A of the 124th OVI. He died of disease and is buried at Stones River National Cemetery.

The Hopkins brothers were Merritt, Milton and Milan. All three were privates in Company E 15th Iowa Volunteer Infantry. Merritt Hopkins died of lung fever 05 March 1864 at Vicksburg, Mississippi unknown burial. Milton Hopkins died of consumption 07 July 1864 and is buried at Keosauga, Iowa. Milan Bartlett deserted at Kingston, NC on 07 April 1865, two days before Robert E. Lee surrendered. His whereabouts afterwards are unknown.

FROM OUR ARCHIVES THE SNEDDEN AND ANDERSON HABERDASHERY





In our photo collection we have two photographs of the above store on the square; they were given to us by member Tom Doyle. The first photo is of the exterior, and one can see to the right the Savings Deposit Bank, which would place the haberdashery where the present Second Sole is located. In the second photograph is the interior and a man standing who is believed to be Ralph Edward Snedden. The store operated from 1921 to 1926; before that it had housed the McDowell Brothers New Model Clothing and Tailor Shop. In 1928 Warren J. Anderson sold the building to his son-in-law Ralph E. and Julia Snedden. Thanks to Bob Hyde and "Beyond the Storefronts" for this information.

Ralph "Jack" Edward Snedden was born Nov 11, 1893, in Cleveland, Cuyahoga County to George Edward and Jessie June Haire Snedden, the oldest of their four children - Irene, Richard and Lois. Soon the family moved to Liverpool Township. He was schooled in the local schools but attended Medina High School and after graduating in 1913 went on to attend Ohio State University, graduating in 1916. While there he was on the staff of the school newspaper and a member of the "Social Committee" of the Junior class. He graduated with a degree in Veterinary Science, and by the time he signed up for the World War I draft registration, was living at 809 South Main Street in Kent, Ohio. He practiced only one year before he entered the United States Army, serving for 19 months as a 2nd Lieutenant in the Veterinary Corps. He was discharged from the Army on August 18, 1919.

After discharge, he was employed as a salesman for the Pollack Tire and Rubber Company of Akron in Bridgeport, Connecticut. He left that company and returned to Medina where he married his high school sweetheart, Miss Julia Anderson, on March 9, 1920. Soon after, he opened the haberdashery with his father-in-law. About 1939 he decided to study law and attended night classes at the Cleveland Law School. Upon receiving his law degree (1934), he and his brother-in-law Edmond Deibel opened their law offices in Medina. Later that year he was elected Medina County prosecutor. He served for two terms. When he registered for the WWII old men draft, he and Julia were living at 509 North Court Street; his law office was at 122 Public Square. He did not serve in the war. Mr. Snedden practiced law until his death in 1956. Julia died sometime before Ralph. Both are buried in the mausoleum at Spring Grove Cemetery.

Mr. and Mrs. Snedden were the parents of two children, Major Hal E. Snedden of Swindon, England, and daughter, Mrs. Elnore Johnson, wife of Robert L. Johnson, also a lawyer and Medina County's representative to the Ohio General Assembly.

Warren J. Anderson was born October 7, 1865, in Montville, Medina County, to Warren and Julia Ann Spellman Anderson. In the 1880 Federal Census he was 14 years old; his occupation was farm laborer. He married Elnor Holben on March 9, 1887; she was the daughter of Joshua and Polly Holben. After their marriage they purchased a farm at 254 East Smith Road in Montville. By the 1910 Census he had established himself in the Stable and Livery business. By 1930 they were living at 519 East Washington, and it appears that he had retired from farming. Mr. Anderson was a member of the Medina Village Council, superintendent of Spring Grove Cemetery for six years, trustee of the Congregational Church and a member of the County Fair Board.

Elnor Holben Anderson died July 9, 1926. Warren Anderson died August 10, 1949 and was survived by one son and two daughters. He and his Elnor are buried in Spring Grove.



The Medina County Historical Society, the Medina County Show Biz Company, and the Medina County Arts Council are joining together to present the annual Walk with the Spirits of the Past. The event is on Thursday, September 7 from 7:00 PM to 8:30PM, and Friday (9/8) and Saturday (9/9) from 7:00 PM to 9:00 PM.

Guides will lead groups of about 20 to different locations around the Medina Square to hear stories of interesting folk from Medina's past.
